# IMPLEMENTATION OF COVID-19 RELATED STANDARD OPERATING PROCEDURES / NPI

Reference is made to our letter of even number dated August 03, 2021 on the above subject.

- With effect from October 01, 2021, the Competent Authority has been pleased to allow serving of in-flight meals / beverages onboard domestic flights operated within Pakistan. However, airline operators will continue to ensure wearing of face masks by passengers onboard all domestic flights within Pakistan except for when meals are being served.
- 3. Other applicable COVID-19 related Standard Operating Procedures / directives issued by Pakistan CAA will continue to take effect.

# IMPLEMENTATION OF COVID-19 RELATED STANDARD OPERATING PROCEDURES / NPI

Reference is made to our letter of even number dated July 19, 2021 mandating Standard Operating Procedures for Domestic Flight Operations within Pakistan.

- 2. In view of the recent surge in COVID-19 cases and in-line with the COVID-19 related NPIs conveyed by the NCOC, effective immediately, there will be a complete ban on serving of in-flight meals to passengers onboard domestic flights operated within Pakistan.
- 3. Additionally, policies on International inbound travel to Pakistan, mandatory vaccination policy for domestic air travel within Pakistan, air travel guidelines regarding safe tourism in Pakistan and any or all air travel policies / directives already in-effect will continue to remain enforced and will be strictly complied with all concerned stakeholders.
- All airline operators are directed to ensure strict compliance.
