# IMPLEMENTATION OF STANDARD OPERATING PROCEDURES (VERSION 4.0) FOR INTERNATIONAL PASSENGER / CHARTERED / PRIVATE AIRCRAFT FLIGHTS

Reference our letter of even number dated June 12, 2021 containing Categorized Country Lists and guidelines concerning inbound travel to Pakistan.

- 2. Revised Category C Country List concerning Inbound travel to Pakistan is being enclosed herewith and will become effective immediately. Accordingly, all Pakistanis whose return to Pakistan from Category C Countries is scheduled till **August 31, 2021**, may travel to Pakistan without grant of a special exemption and while in possession of valid negative PCR Test Result conducted within the 72 hours prior to commencement of travel to Pakistan, subject to conformance with all other applicable rules / regulations. Inbound travel to Pakistan from Category C Countries for all other passengers will continue to remain banned.
- 3. Any or all passengers arriving in Pakistan will, however, be subjected to Testing and Quarantine stipulations as per procedure in-vogue.
- All concerned are directed to ensure strict compliance.
